E Terms and Conditions of All Sales on Credit								
<p>In consideration of being permitted to effect purchases on my (our) account(s) up to a credit limit which will be determined by Nedco, a Division of Rexel Canada Electrical Inc. (hereinafter "Nedco"), at its sole discretion, I (we) as Customer agree to the following conditions:</p> <p>I (we) shall pay all invoices in accordance with the terms stated on such invoices by Nedco. Nedco's terms and conditions of all sales on credit shall prevail notwithstanding anything that may be stated to the contrary on the Customer's order, receipt, bill of lading or other document provided by the Customer.</p> <p>I (we) hereby agree to pay administration charges of 2% per month (26.8% per annum) on the amount of any overdue balance in my (our) account(s) from the date such balance(s) become(s) overdue. I (we) hereby agree to pay all costs of collection and/or legal fees, in the event such actions become necessary to recover the balance(s) owed in my (our) account(s).</p> <p>A Return Authorization must be obtained before goods may be returned for credit. Restocking charges will apply on all goods returned. Reference must also be made to our original invoice number.</p> <p>I (we) agree that every statement of account shall be deemed and treated as authorized and correct, unless a written notice to the contrary is received within fifteen (15) days from the date of such statement.</p> <p>The Customer agrees that title to the goods supplied by Nedco shall remain the property of Nedco, until such goods have been paid in full by the Customer and where applicable under provincial laws, Nedco shall have a continuing security interest or purchase money security interest, lien or hypothec in all such goods and their proceeds to secure the performance by the Customer of all its obligation to Nedco. The customer waives its right to receive a copy of any Financing Statement and Verification Statement.</p> <p>All changes in my (our) company's structure and/or its owners and shareholders will be immediately reported to Nedco, in writing.</p> <p>I (we) hereby authorize Nedco to conduct or cause to be conducted, as required, credit investigations on myself (ourselves), my (our) company(ies) and any related persons or Companies, also to disclose credit references to other creditors as requested, with regards to the credit line established and the history of payments on account.</p> <p>Notice – Consent: Nedco understands the importance of protecting your privacy.
